<u>FINDMYPAST.CO.UK_PUBLISHES NEW TITANIC RECORDS_</u>- White Star Line Officers' books that_were due to be destroyed made available online for the first time

Leading family history website <u>findmypast.co.uk</u> has published two new fascinating sets of records, which include information about the passengers and crew aboard the Titanic's ill-fated maiden voyage. The <u>Maritime birth, marriage and death records</u> and <u>White Star Line Officers' books</u> are both available from today.

Debra Chatfield, family historian at <u>findmypast.co.uk</u>, said: "These fantastic new additions to <u>findmypast.co.uk</u> will be of immense value not only to people with ancestors who were employed at sea, but also to anyone who has been struggling to find a record of an ancestor's birth, marriage or death. There has never been a single centralised register of births, marriages and deaths at sea, so many of the names listed in these records will not appear in the information already available online."

From Crofts to Castles - Valuation Rolls in Scotland Go Online for the First Time. - Please find below a news release for the launch of the Valuation Rolls in Scotland for 1915 on the ScotlandsPeople website. Images, case studies, background information and statistics can all be accessed at the ScotlandsPeople Media Website: http://media.scotlandspeople.gov.uk/index.html

The case studies contain interesting and quirky stories about famous Scots and Scottish families who appear in these historical records - including Ewan McGregor, Paolo Nutini, Alastair Sim, Brian Cox, Donald Trump, William Speirs Bruce and Lawrence 'Laurie' Auchterlonie.

The case studies also include interesting stories about historic buildings, football grounds and famous country estates.

BAPTISMS, MARRIAGES AND BURIALS FROM WELSH ARCHIVES PUBLISHED ONLINE FOR THE FIRST TIME - leading family history website findmypast.co.uk has announced the launch of the first tranche of parish records from Wales - part of a major new project with the Welsh County Archivists Group and the National Library of Wales.

3,878,862 million records from parish registers from the Church in Wales can now be searched for the first time online from today comprising: 1,418,921 baptism records covering 1538-1911 950,254 marriage records covering 1539-1926 340,002 marriage banns covering 1701-1926 1,169,685 burial records covering 1539-2007 These records cover the counties of Cardiganshire, Carmarthenshire, Denbighshire, Flintshire and Glamorganshire.

Your Committee will be nominating Deputy Convenor Clive Palmer as a Council member and several of us will be travelling to Taupo to support him. The AGM commences 1pm with registration and we are arranging transport to and from Taupo on that day. Any NZSG member who wishes to join the support group should contact our Secretary Lyn Lee.

Our two monthly presentation. – Was on services available to members of the NZ Society of Genealogists (NZSG) covered Documents Online, one of the more recent additions to the benefits of membership of our national body. Documents Online is the online branch of the UK National Archives covering 1000 years of history. Anything you can find on there that is available for download for a fee may instead be requested for a free download, via the NZSG research officer.

Lorna provided a brief overview on how to search Documents Online, obtain the necessary references, and then request your free download from NZSG. There are some gems to be found in there, eg the service records of two sisters, both nurses, from New Zealand elicited the information that one was of a "difficult disposition" and the other had "an interesting history", along with the more prosaic and expected service history.
