CONVENERS COMMENT:-

Our July 25 Branch session has changed from that advertised. Member Bill Carter will give us a presentationon"TalkingtotheOlds"coveringthe techniques,do's and don'tsofasking althose awkward questions to your elders, about the family. I'veheardthispresentation before and can strongly recommend it.

Those who joined NZSG EO, Peter Nash, at our June meeting, will have heard a refreshing, no nonsense resume of the Society and its future. Questions were lively throughout and I believe cleared the air on many issues. The key point was that the Society was evolving from an 'aroundthe kitchentable' operationandwhererecordswere kept 'underabed', toaprofessional, accountable and marketable organization.

Access to the Internet for example, had changed radically the way people conducted their genealogy research and provided a huge range of competitive free and user-pays international products. Meeting these challenges required a range of initiatives and included the establishment of the Family Research Centre and outreach programmes and road shows to districts.

Volunteers however would always be the principal delivery mode of activities, so there

were limits to the resource capital. Improvements to the website to provide more interactive access to resources were about to be launched. Subscriptions would never cover financial requirements and so greater emphasis was being placed on saleable products such as publications, CDs of research data and others. This had seen a dramatic improvement in cash flow in the previous financial year.

The Constitution was under continuing review to meet the times. The structure of Branches remained in the hard basket but would be addressed eventually. The magazine remained the biggestcalontheSociety's finances and would need some lateral thinking to cope with a variety of demands from members. Council now acted more like a Board of Directors concerned with policy and not with the cover colour of the next publication. Daily management was in the hands of the EO. Watch this space!

We are well through our financial year and it's time to start thinking ahead. Several Committee members have indicated they would like a well-earned break and so here is my annual plea for you to offer your help on the next committee. I guess a sign of the times is that even with a membership of 220 we have difficulty getting active support to continue with our plans to expand our resources and activities. Please give it some thought. The AGM in October is only three months away.

Using RootsWeb:

Demystifying Mailing Lists and Message Boards

Every RootsWeb user, at one time or another, probably has made use of two of RootsWeb's most popular features -- the free mailing lists and message boards. However, some are confused by

the need to have both resources. Frequently asked questions are: Why do we need both lists and boards? What are the differences between the two? Which should I use?

Lists and boards are resources for posting genealogical queries and awaiting possible answers to your research questions. Both can serve as repositories for genealogical data. But there are differences in their usage and there are instances in which one would be better than the other for posting your queries and data.

Message boards are generally the best place for transcriptions of data/documents. You can even add a graphic copy of the original document as an attachment. Documents such as deeds, wills, military pension papers, family Bible records, and public domain biographies are all easily copied to the boards for archiving purposes so that they can be accessed by future researchers who browse or search the message boards. Queries posted to message boards can represent anything from an attempt to knock down a long-standing brick wall by a serious researcher to a casual query about a collateral line or the spouse of a distant cousin.

Since a researcher doesn't have to subscribe to a message board in order to post a query on it, he can post queries that are only of passing interest as well as important research questions.

When posting to a message board, patience is the keyword. Message board posts might be found weeks, months, or even years later by another researcher with the answer to your question or by someone who possesses the puzzle piece you need to solve a mystery. It is important to keep email contact addresses current on old message board posts for this very reason. It is quite easy to do so through the use of registration and keeping your account data up-to-date.

Mailing lists are an e-mail forum for discussion among a group of researchers who subscribe to a list. Those on a mailing list receive all messages posted to a list by others. Since you must subscribe to (join) a list in order to post or receive messages from it, lists are relatively immune to spam and other undesirable content. Mailing lists function more "in the moment" than message boards do. The "real-time" discussion on a list often includes queries and responses on a specific thread until all aspects of the initial query have been thoroughly answered or covered. You will

often find resident experts on a list who are well-informed and helpful.

If you subscribe to mailing lists, remember that it is not possible to update your e-mail contact address should it change on old posts already housed in the mailing list archives. So, if your address changes, it is wise to re-post old queries in cases where you are still looking for the information.

One valuable tool to aid mailing list subscribers in viewing message board posts is the "gateway," which makes board posts available on a corresponding list with a link to permit replying on the board. The boards that make use of the gateway option carry a yellow highlighted notation to that effect as well as a yellow envelope icon. For many researches, list and board gatewaying provides the best of both worlds by playing to the strengths of both the message board and mailing list forums.

Don't just post once to a board or list and wait for answers. Keep your posts fresh and update them as you learn additional facts. Also, remember to give help as well as ask for it - that's what these forums are all about. LDS Family History Centre

Saturday 8th July 11 members of the Kapiti group visited the LDS Family History Centre at Totara Park. Mavis Pakai gave an introduction to why the church collects the records. She showed a photograph of the enormous Granite Mountain Records Vault outside Salt Lake City in Utah where the original records are stored. All records are being digitised and will eventually go on line.

Copies of any of their two million rolls of microfilm can be ordered at \$5.50 per film and viewed at Family History Centres over a period of three weeks. Gene Pene talked about access to the material held in the Centre saying that all Centres do not hold the same material so that if visiting another city it would be worth visiting to see what is held. The Family History Centres are not lending libraries; all material must be viewed on site. Gene said it is important to understand the Family History Catalogue, searchable on www.familysearch.org. It is the window to the largest collection of material in the world. Volunteers run the Family History Centres. There is no charge to enter but costs for printing and copying are recovered. The phone number for Totara Park is 04 526 4259 and opening hours: Wednesday & Thursday, 10am - 2pm, 6-10pm Saturday, 8.30am to 12.30 pm.

The next visit will be to the Alexander Turnbull Library on Wednesday 13th September. Further details later.
