IT'S A PUZZLEMENT

I have a couple of Wills, which, as far as I can see, are those of a grandfather and grandson, as the latter was born the year the former died, and the grandfather's Executor was his son. To complicate matters they were all called William, and, unfortunately, no other family members were mentioned.

According to information received, William the First was bom in 1631 or 1632 and died in 1696. He was married to Elizabeth in 1663, but she died in 1677 and in the Will he makes provision for "his wife, Susan", so he must have remarried.

William the Second is the Missing Link, born circa 1662 and died in 1699, three years after William the First.
